On the decision of the National Security and Defense Council of Ukraine dated March 4, 2016 "On the Concept of the Development of the Security and Defense Sector of Ukraine"

According to Article 107 Constitution of Ukraine, part two Article 2 of the Law of Ukraine "On the Basics of National Security of Ukraine" **provides**:

- 1. To implement the decision of the National Security and Defense Council of Ukraine from March 4 of 2016 "On the Concept of Development of the Security and Defense Sector of Ukraine" (attached).
 - 2. To approve the Concept of the development of the security and defense sector of Ukraine (attached).
- 3. To recognize that the Decree of the President of Ukraine dated December 29, 2012 No. 772 has lost its validity "On the decision of the National Security and Defense Council of Ukraine dated December 29, 2012 "On the Concept of Reform and Development of the Armed Forces of Ukraine for the period until 2017".
- 4. Control over the implementation of the decision of the National Security and Defense Council of Ukraine put into effect by this Decree shall be entrusted to the Secretary of the National Security and Defense Council of Ukraine.
 - 5. This Decree enters into force from the day of its publication.

CONCEPT of development of the security and defense sector of Ukraine

I. GENERAL PROVISIONS

This Concept defines a system of views on the development of security and defense capabilities of Ukraine in the medium-term perspective, formed on the basis of an assessment of the security environment and financial and economic capabilities of the state, carried out as part of a comprehensive review of the security and defense sector of Ukraine.

The legal basis of the Concept is the Constitution and laws of Ukraine, National Security Strategy of Ukraine, approved by the Decree of the President of Ukraine dated May 26, 2015 No. 287, and the Military Doctrine of Ukraine, approved by the Decree of the President of Ukraine dated September 24, 2015 No. 555.

The purpose of the Concept is to determine the ways of forming national security and defense capabilities that will make it possible to restore the territorial integrity of Ukraine within the internationally recognized state border of Ukraine, guarantee the peaceful future of Ukraine as a sovereign and independent, democratic, social, and legal state, as well as ensure the creation of a national response system to crisis situations, timely detection, prevention and neutralization of external and internal threats to national security, guaranteeing personal safety, constitutional rights and freedoms of a person and citizen, ensuring cyber security, prompt joint response to crisis and emergency situations.

The implementation of the specified goal will be achieved by:

creation of an effective management system of the security and defense sector as a whole functional system;

unification of the operational capabilities of the components of the security and defense sector to ensure a timely and adequate response to crisis situations that threaten national security;

constant maintenance of designated security and defense forces in readiness for execution assigned tasks;

improvement of the planning system in the security and defense sector, ensuring rational use of state resources.

The main efforts for the development of the security and defense sector will focus on the gradual and coordinated increase in the operational capabilities of the security forces and

of defense and their level of readiness for immediate response to challenges and threats to Ukraine's national security.

The components of the security and defense sector should be defined as:

President of Ukraine;

National Security and Defense Council of Ukraine;

Ministry of Defence Ukraine;

Armed Forces of Ukraine;

Ministry of Internal Affairs of Ukraine;

National Guard of Ukraine;

National Police of Ukraine;

State Border Service of Ukraine;

State Migration Service of Ukraine;

State Service of Ukraine for Emergency Situations;

Security Service of Ukraine;

State Security Office of Ukraine;

State Service of Special Communications and Information Protection of Ukraine;

State special transport service;

coordinating body for intelligence activities under the President of Ukraine and intelligence agencies of Ukraine;

Apparatus of the National Security and Defense Council of Ukraine;

the central body of executive power, which ensures the formation and implementation of the state military-industrial policy;

other components defined by the laws of Ukraine.

It is intended to create conditions for the widespread involvement of non-governmental organizations in the performance of tasks in the interests of national security and defense of the state. The most promising areas of their activity should be: provision of services in the interests of the fulfillment of peacekeeping tasks by the Armed Forces of Ukraine; the functioning of a network of non-state research institutions specializing in security and defense issues, etc.

II. PRINCIPLES OF SECURITY AND DEFENSE SECTOR DEVELOPMENT

1. Assessment of the security environment

The following threats will remain the most relevant in the medium term:

Russia's aggressive actions, which are carried out to deplete the Ukrainian economy and undermine sociopolitical stability with the aim of destroying the state of Ukraine and seizing its territory, using military force, as well as technologies of hybrid warfare;

the temporary occupation by the Russian Federation of the territory of the Autonomous Republic of Crimea and the city of Sevastopol and further actions to destabilize the situation in the Baltic-Black Sea Caspian region;

intelligence-subversive and subversive activities of the Russian Federation and other states, actions aimed at inciting inter-ethnic, inter-confessional, social enmity and hatred, separatism and terrorism, creation and comprehensive support of puppet quasi-state entities in the temporarily occupied territory of part of the Donetsk and Luhansk regions;

the buildup by the Russian Federation of military groups near the state border of Ukraine and on the temporarily occupied territory of Ukraine, including the deployment of tactical nuclear weapons on the Crimean peninsula;

activities of extremist criminal armed groups on the territory of Ukraine aimed at destabilizing the internal socio-political situation in Ukraine, disrupting the functioning of state authorities, local self-government bodies and blocking important industrial and infrastructure facilities;

it is possible to use the territory of Ukraine to conduct hostilities in case of occurrence military conflict between NATO member states and the Russian Federation.

The security challenges that may increase the threat of using military force against Ukraine are:

the destruction of the international security system as a result of the aggressive actions of the Russian Federation and the insufficient efficiency of the world security structures;

interference in the internal affairs of Ukraine by the Russian Federation, aimed at changing the constitutional order, violating the territorial integrity and sovereignty of Ukraine, socio-political stability and law and order;

attempts by the Russian Federation to destabilize the socio-political and economic situation in Ukraine, as well as to provoke separatist sentiments in the areas of compact residence of national minorities on the territory of Ukraine:

opposition to the implementation of the European choice of the Ukrainian people, the formation of systems collective security with the participation of Ukraine;

unresolved issues regarding the delimitation of the state border between Ukraine and the Russian Federation in the waters of the Black and Azov Seas, the incompleteness of the contractual legalization of the state border of Ukraine with the Russian Federation, the Republic of Belarus and the Republic of Moldova;

blocking by the Russian Federation and its satellites of Ukraine's initiatives to involve the world community in the settlement of the conflict in the east of the state, in particular, in relation to the involvement of the peace and security forces of the UN and the EU;

complicating or discrediting the work of the Special Monitoring Mission of the OSCE in Ukraine, other international observation, monitoring, mediation organizations accredited in Ukraine;

purposeful informational (informational and psychological) influence on the formation of a negative international image of Ukraine, destabilization of the internal socio-political situation, aggravation of inter-ethnic and inter-confessional relations in Ukraine or its individual regions and places of compact residence of national minorities;

implementation by foreign states and international criminal groups of cyber threats against automated systems of state and military administration, objects of critical information infrastructure;

increase in the level of terrorist threats in the Baltic-Black Sea-Caspian region;

spread of cross-border organized crime;

crisis phenomena in the national economy, the ineffectiveness of anti-crisis measures, which lead to the depletion of the state's financial resources, limit its opportunities for financial support for the implementation of the state national security policy.

The main form of hybrid war against Ukraine is a combination of diverse and dynamic actions of the regular forces of the Russian Federation interacting with criminal armed groups and criminal elements, whose activities are coordinated and carried out according to a single plan and plan with the active use of means of propaganda, sabotage, intentional harm, sabotage and terror.

2. The main tasks of the security and defense sector

The main tasks of the security and defense sector are:

defense of Ukraine, protection of its state sovereignty, territorial integrity and inviolability;

protection of the state border of Ukraine;

protection of the constitutional system, the economic, scientific, technical and defense potential of Ukraine, the legitimate interests of the state and the rights of citizens from intelligence-subversive activities of foreign special services, encroachments by certain organizations, groups and individuals, as well as ensuring public safety and protection of state secrets, other information with limited access;

prevention, detection, termination and disclosure of crimes against the peace and security of humanity, other illegal actions that directly threaten the vital interests of Ukraine, the fight against terrorism, corruption and organized crime in the sphere of management and economy;

ensuring information and cyber security;

providing assistance to executive authorities and local self-government bodies in the prevention and liquidation of the consequences of natural and man-made emergencies, as well as of a military nature, development of international cooperation in this area;

participation in ensuring international stability and security.

3. Assessment of the state of the components of the security and defense sector

The current state of the components of the security and defense sector does not allow to ensure guaranteed response to current threats to the national security of Ukraine.

Unsolved problems in the security and defense sector remain:

ineffectiveness of the mechanism of prevention and neutralization of modern threats to the national security of Ukraine;

long-term financial and material support of the components of the security and defense sector according to the residual principle, imperfection of the process of formation, coordination and interaction of the components of the security and defense sector when solving joint tasks for ensuring national security;

incompleteness of the process of building an effective resource management system crisis situations that threaten national security;

an imperfect system of planning and joint use of troops (forces) and means, their training and support;

imperfect and ineffective interaction between central and local authorities state authorities, primarily in matters of preventing and combating terrorism;

lack of effectiveness of the subjects of the security and defense sector of Ukraine in countering cyberthreats of a military, intelligence, criminal, terrorist and other nature;

non-compliance with modern challenges of the unified state system of civil defense and civil defense forces and their technical equipment.

Overcoming these problems is expected through purposeful reform and development of the security and defense sector with the introduction of a unified system of planning and resource management based on modern European and Euro-Atlantic approaches, which will make it possible to increase its institutional and structural balance and create an effective complex and multifunctional state toolkit for ensuring national security.

4. Development directions of the security and defense sector

The level of ensuring Ukraine's national security depends primarily on the effectiveness of the functioning of the relevant state authorities, the clear distribution of responsibilities and powers in certain areas of activity, and the established interaction between them.

Determining the principles underlying the development of the security and defense sector regarding integration into European and Euro-Atlantic security structures, Ukraine assumes that the development and strengthening of the EU and NATO deepen pan-European and international security in all its dimensions and require appropriate democratic transformations of national security institutions

For the effective development of the security and defense sector in modern conditions, it is assumed:

improvement of the conceptual and doctrinal principles of training and use of troops (forces) and means of the security and defense sector;

centralization of the management of the security and defense sector in peacetime, in crisis situations threatening national security, and in a special period, increasing the level of interdepartmental coordination and interaction:

coordination of concepts, strategies and programs of reform and development of the components of the security and defense sector and the defense-industrial complex;

ensuring effective coordination and functioning of the state crisis system reaction;

improvement of the system of state forecasting and strategic planning, the system of planning the use of troops (forces) and means of the security and defense sector based on the principles and standards of the EU and NATO;

creation of a unified platform of secure electronic communications of state authorities;

creation and implementation of a strategic communications system in the security and defense sector;

introduction of an integrated system of education, combat and special training of personnel in the security and defense sector with the involvement of teachers, instructors from NATO and EU member states, formation of a new security culture with the preservation, if necessary, of specialization and individualization of the personnel training system;

establishment and maintenance of cooperation with authoritative international organizations and states aimed at neutralizing the negative consequences of direct, non-conventional, hybrid and other acts of aggression against Ukraine;

improvement of budget policy in the security and defense sector through the rational distribution of expenditures for development, combat training and operational activities in accordance with the best practices of NATO member states:

application of a programmatic approach to determining the amount of financial and material and technical resources necessary for the effective functioning of the security and defense sector;

increasing the professional level of the personnel of the security and defense sector, ensuring their high motivation to properly perform assigned tasks;

optimization of the number of units providing components of the security and defense sector in within the unified system of logistics support;

improvement of the system of democratic civilian control over the security and defense sector, strengthening of parliamentary control;

ensuring the development of the system of military-patriotic education, the introduction of programs of military training and civil defense in general education, vocational and technical educational institutions.

III. MAIN TASKS OF SECURITY AND DEFENSE SECTOR DEVELOPMENT

1. Formation of a perspective model of the security and defense sector

The President of Ukraine is the head of state, ensures state independence, national security and legal succession of the state, is the Supreme Commander of the Armed Forces of Ukraine, appoints and dismisses from positions above the command of the Armed Forces of Ukraine, other military formations formed in accordance with the laws, exercises leadership in the spheres of national security and State Defense, heads the National Security and Defense Council of Ukraine, exercises other powers specified by the Constitution of Ukraine in the field of ensuring national security and defense. Carrying out leadership in the field of national security and defense, the President of Ukraine will determine the strategic goals and main tasks of the state policy in the field of national security and defense of Ukraine, the tasks of the components of the security and defense sector in peacetime, in crisis situations that threaten national security, and in a special period, goals and priority directions of development of the components of the security and defense sector, goals, tasks, terms of approval of planning documents for the development of the security and defense sector and its components.

The main goal of the reform and development of the security and defense sector is the formation and maintenance of capabilities that will make it possible to guarantee an adequate and flexible response to the entire range of threats to the national security of Ukraine, rationally using the state's available opportunities and resources.

To achieve the defined goal, it is planned to implement a set of tasks, which consist of:

introduction of management of the security and defense sector on the basis of the adopted EU and NATO member states of principles and standards;

compliance with the principles of the rule of law, patriotism, competence and departmentalization in the functioning of the security and defense sector, ensuring its reformation and development in compliance with the principles of democratic civilian control;

increasing the level of coordination and cooperation in the security and defense sector;

implementation of an effective unified system of resource planning and management using modern European and Euro-Atlantic approaches;

acquired by the forces and means of the security and defense sector of defined basic operational (combat, special) capabilities necessary for a guaranteed response to crisis situations that threaten national security;

ensuring the priority development based on the coordinated functioning of the intelligence agencies of Ukraine's intelligence capabilities with regard to the timely detection of actual threats to national security;

assigning to the coordination body for intelligence activities under the President of Ukraine the powers of general management of the intelligence community, establishment of general standards for its subjects, specification and distribution of tasks, implementation of control over the activities of intelligence agencies, as well as preparation of agreed intelligence assessments for the state leadership;

formation of a unified system of logistical support capable of centrally managing resources in the interests of providing troops (forces) and means of the security and defense sector during their operational use;

creation of a national cyber security system;

implementation of the professionalization of the defense forces and the creation of the necessary military reserve;

ensuring the most expedient consolidation of law enforcement activities in the sphere of responsibility of the Ministry of Internal Affairs of Ukraine, increasing the level of trust of citizens in law enforcement agencies, developing the Ministry as a civilian central body of executive power that ensures the formation and implementation of policy in the field of law enforcement activities, protection of the state border, migration activities and civil protection;

the effective performance by the National Police of Ukraine as the central body of the executive power of functions in the areas of combating crime, in particular organized crime, and ensuring public order;

improving and ensuring the effective functioning of the unified state system civil protection, bringing it into line with the standards of the European Union;

ensuring the effective implementation of the security policy in the sphere of protection and protection of the state border of Ukraine, as well as protection of the sovereign rights of Ukraine in its exclusive (maritime) economic zone;

ensuring the rights and freedoms of citizens, providing high-quality administrative services, effective control over migration processes, effective fight against illegal migration, promoting the introduction of a visa-free regime with the European Union;

strengthening cooperation with partner special services of NATO member states, in particular taking specific measures of mutual trust.

The distribution of responsibilities of the components of the security and defense sector of Ukraine for the organization of planning, response to threats and during the performance of assigned tasks is specified in the appendix to this Concept.

2. Ways of achieving the necessary capabilities

The main ways of achieving the necessary operational and other capabilities components of the security and defense sector are:

improvement of the legislative framework on the functioning and development of the sector security and defense, taking into account the relevant principles and standards of the EU and NATO;

timely development and implementation of program documents for the development of components of the security and defense sector, taking into account the planned transition to EU and NATO standards;

rational distribution of tasks in the security and defense sector, formation of a system of management of security and defense forces depending on the type of crisis situation and taking into account the multifaceted nature of risks to national security;

achieving and maintaining the necessary level of combat and mobilization readiness of the troops (forces) and law enforcement agencies to perform tasks as assigned, bringing them closer in terms of composition, level of training and equipment with weapons, military and special equipment to EU and NATO standards;

increasing the capabilities of the National Guard of Ukraine to perform the tasks of maintaining public safety, physical protection of critical infrastructure objects, participation in the protection and defense of the state border of Ukraine, as well as supporting the operations of the Armed Forces of Ukraine in crisis situations that threaten national security and in a special period;

improvement of the system of planning the use, management and interaction of security and defense forces during the elimination (neutralization) of current threats;

creation of a unified system of situation centers of state bodies that are part of the security and defense sector, as well as other state and local authorities, ensuring its effective coordination using the capabilities of the Main Situation Center of Ukraine, creating conditions for ensuring the interaction of this system with the NATO Situation Center (SITCEN);

improvement of state administration and management of the security and defense sector, including information and cyber security systems, information protection systems and security of information resources;

carrying out a review of the sphere of strategic communications of the security and defense sector and its improvement taking into account the experience of NATO member states;

software needs of information and communication technologieschaolagiessed for the the security and defense sector, broad involvement of the private sector and volunteer movements for this purpose;

increasing the level of integration and coordination of activities of subjects of the intelligence community, the effectiveness of their management by the coordination body on intelligence activities under the President of Ukraine;

strengthening the capabilities of intelligence and counterintelligence bodies, including by creating organizational, material, technical and financial conditions to improve their operational capabilities in priority areas of operational and service activity;

acquisition of operational and technical compatibility by the determined composition of forces and means of the sector of security and defense with relevant divisions of NATO and EU member states;

increasing the level of individual professional training of the personnel of the bodies state and military administration, its responsibility for decision-making;

improvement of the system of territorial defense in order to form an active reserve of the Armed Forces of Ukraine, introduction of a practical model of interaction of territorial defense units with the armed forces of the state;

creation of a system of monitoring, analysis, forecasting, modeling and decision-making support in the field of national security and defense according to uniform methods prepared using the capabilities of the Main Situation Center of Ukraine;

reforming the state administration system for a special period by optimizing the number of control points, adapting their communication and automation systems, creating mobile control points; C2 reform?

increasing the effectiveness of scientific and scientific and technical activities in the interests of security and defense, creating conditions for the growth of the production potential and capacities of the defense industrial complex of Ukraine with the aim of deploying its own production of weapons, military and special equipment;

ensuring innovative development of the defense-industrial complex;

creation of effective means of protection of military facilities and weapons, military and special equipment, countermeasures against foreign technical intelligence;

increasing the efficiency of operation and repair of weapons, military and special equipment;

strengthening the capabilities of the subjects of the security and defense sector to effectively combat cyber threats of a military nature, cyberespionage, cyberterrorism and cybercrime, strengthening the institutional and technical capabilities of such subjects, deepening international cooperation in this area;

development of a computer emergency response network (CERT);

increasing the capacity of the State Emergency Service of Ukraine to effectively manage the unified state system of civil protection, equipping the civil protection forces with modern types of equipment, means and equipment;

creating and ensuring the effective functioning of the mobilization resource training system;

restoration based on revised and optimized indicators of military, operational and strategic stocks of material and medical property, food, fuels and lubricants;

increasing the efficiency of training of scientific personnel and the functioning of the personnel support system for scientific, technological and educational activities in the security and defense sector;

improvement of the system of social protection of military personnel, employees and employees of the security and defense sector, as well as their family members.

The domestic defense-industrial complex plays a leading role in maintaining a high level of combat and mobilization readiness of the forces and means of the security and defense sector, increasing their operational capabilities by modernizing existing and supplying new types of weapons, military and special equipment, modern means of communication and information protection .

3. The main directions of development of the components of the security and defense sector

3.1. Ministry of Defence Ukraine

The Ministry of Defense of Ukraine will continue to be the main body in the system of central executive bodies, which ensures the formation and implementation of state policy on national security issues in the military sphere, the sphere of defense and military construction, as well as the vital activities of the Armed Forces of Ukraine, their functioning, combat and mobilization readiness, preparation for the performance of tasks assigned to them.

The Armed Forces of Ukraine are subordinate to the Ministry of Defense of Ukraine as a military management body.

The further development of the Ministry of Defense of Ukraine will be carried out in accordance with the legislation of Ukraine in the field of defense and the conceptual and program documents of defense planning approved in the prescribed manner, developed taking into account the principles applied in NATO.

3.2. Armed Forces of Ukraine

Important part for the reform objectives of the AFU + timeline

The reform and development of the Armed Forces of Ukraine is planned to be carried out within the framework of unified approaches to the formation of the state's defense capabilities, ensuring their leading role in the performance of defense tasks.

For this purpose, it is planned to carry out:

optimization of the structure and number of the Armed Forces of Ukraine;

restoring the technical readiness of weapons, military and special equipment, modernization and renewal of their composition;

improvement of the system of training troops (forces);

reforming the system of operational (combat) and logistical support;

ensuring interoperability with other components of the security and defense sector in joint actions within defined scenarios;

gradual convergence of the Armed Forces of Ukraine in terms of training and technical indicators equipment and comprehensive support to NATO standards.

The implementation of the tasks of reforming and developing the Armed Forces of Ukraine involves:

in the first stage (until the end of 2017):

optimization and increase of combat capabilities of existing and formation of new military units;

reforming the system of managing troops (forces) to ensure the management of inter-species associations of the Armed Forces of Ukraine;

the creation of the Special Operations Forces as a separate type of troops by direction, determined by the Concept of formation and development of Special Operations Forces;

creation of new functional structures of the Armed Forces of Ukraine (immediate forces response, build-up forces, reserve forces);

preparation of immediate response forces to cover the state border of Ukraine, containment, localization, liquidation (neutralization) of the armed conflict, ensuring the deployment of the Armed Forces of Ukraine in the event of a threat of armed aggression;

preparation of reinforcement forces for strengthening (increasing) groupings of troops (forces) in relation to elimination of armed conflict and repelling armed aggression;

preparation of reserve forces for use by the decision of the command of the Armed Forces of Ukraine in a special period and/or during an anti-terrorist operation, as well as to provide assistance during natural disasters and man-made disasters:

restoration of the military infrastructure, revision of the locations of permanent deployment units and military units of the Armed Forces of Ukraine, taking into account the modern security environment;

formation of a system of autonomous military bases on the basis of military towns with the necessary infrastructure for the location of military units, a fund of service housing and social and household facilities for servicemen and their family members;

creation of an effective system of mobilization and mobilization training with the necessary number of military commissariats and the number of employees and with a single state register of conscripts;

creation of appropriate conditions to ensure the gradual staffing of the Armed Forces of Ukraine with servicemen under contract;

achieving the level of ability of troops (forces) to respond adequately to threats of border armed conflict and maintaining the ability to increase operational capabilities in a special period to repel armed aggression against Ukraine; start war 22 was messy, but did every unit know what they were supposed to do? increasing the combat potential, restoring serviceability, extending the resource, carrying out modernization, creating new systems and unifying samples of weapons and military equipment of the Armed Forces of Ukraine;

formation of cyber security and cyber defense units of the Armed Forces of Ukraine, implementation of interdepartmental coordination on these issues in the interests of ensuring the state's defense capability;

in the second stage (until the end of 2020), it is planned to gradually build up the capabilities of the Armed Forces of Ukraine for prevention, deterrence and localization at an early stage of a military conflict by:

maintaining and increasing the combat capability of military units of constant readiness in accordance with NATO standards;

transfer of the military management bodies of the Armed Forces of Ukraine to the J-structure adopted as a basis in the headquarters of NATO member states, separation in the management system of functions related to the formation, training and development of forces from functions related to their use, corresponding reforming of the management bodies of other components of the defense forces;

further equipping the Armed Forces of Ukraine with modernized and new weapons and military equipment, taking into account needs and defined priorities;

improvement of the information security system of the Ministry of Defense of Ukraine and the Armed Forces of Ukraine;

improvement of the training system of troops (forces), achievement of combat training indicators according to NATO standards;

organization of the development of modern samples of weapons and military equipment, means communication, informatization and information protection;

strengthening the capabilities and level of readiness of special operations forces, emergency forces response, reinforcement forces and reserve forces to perform assigned tasks;

implementation of modern systems and technologies of comprehensive provision of troops (forces).

In the future, the development of the Armed Forces of Ukraine will be aimed at:

achieving quality indicators of their new model, equipping with modern models weapons and military equipment;

intensification of training and professionalization;

increasing the level of operational interoperability with units of the armed forces of NATO and EU member states and readiness to perform joint tasks in operations to maintain peace and security;

creation of the necessary material and technical reserves for adequate response, together with other components of the security and defense sector, to all challenges and threats, ensuring the ability to counter information, cybernetic attacks, special operations of the enemy, as well as active participation in international measures to maintain peace and security.

3.3. Ministry of Internal Affairs of Ukraine

The goal of the development of the Ministry of Internal Affairs of Ukraine at the current stage is its establishment as the main body in the system of central executive bodies, which ensures the formation of state policy in the following areas:

ensuring the protection of human rights and freedoms, the interests of society and the state, combating crime, maintaining public safety and order, as well as providing police services;

protection of the state border of Ukraine and protection of Ukraine's sovereign rights within it exclusive (maritime) economic zone;

civil protection, protection of the population and territories from emergency situations and prevention of their occurrence, liquidation of emergency situations, rescue work, extinguishing

fires, fire and man-made safety, activities of emergency and rescue services, as well as hydrometeorological activities;

migration (immigration and emigration), including combating illegal (illegal) migration, citizenship, registration of individuals, as well as refugees and other legally defined categories of migrants.

To achieve this goal, it is assumed:

in the first stage (until 2017):

conduct an audit of the material, technical and financial security of the internal affairs bodies of Ukraine in order to identify systemic problems for the further formation of the budget of the Ministry of Internal Affairs of Ukraine and the protection of personnel rights;

to form and normatively consolidate the status and functions of the universal special unit;

introduce additional measures to ensure the rights of detainees and arrestees persons in accordance with European norms;

introduce the practice of video recording the first interrogation of a detainee and the only one electronic protocol (custody records);

introduce new standards of physical and fire training of personnel;

to reorganize the procedure for citizens' electronic access to the regulatory framework of internal affairs bodies based on open interactive GIS resources;

to develop a policy for assessing the quality of the provision of law enforcement services;

introduce new criteria for assessing the effectiveness of the Ministry of Internal Affairs of Ukraine;

in the second stage (until 2020):

introduce information and communication technologies for management and auditing material, technical and financial security of internal affairs bodies;

complete a major redeployment and downsizing taking into account European practices;

to test the model of the institute of secondary employment of personnel;

to ensure the gradual transformation of educational institutions of the Ministry of Internal Affairs of Ukraine.

3.4. National Guard of Ukraine

In accordance with the best European practices, the National Guard of Ukraine will enter the system of the Ministry of Internal Affairs of Ukraine as a military formation with law enforcement functions.

Its main tasks are the protection and protection of life, rights, freedoms and legitimate interests of citizens, society and the state from illegal encroachments, protection of public order and provision of public safety, as well as participation together with other bodies in activities

regarding the provision of state security and protection of the state border, cessation of terrorist activities, activities of illegal paramilitary or armed formations, organized criminal groups and organizations.

The National Guard of Ukraine, in cooperation with the Armed Forces of Ukraine, will participate in accordance with the law in repelling armed aggression against Ukraine and liquidating the armed conflict by conducting military (combat) actions, as well as in the performance of territorial defense tasks.

During martial law, the National Guard of Ukraine is subordinate to the Ministry of Defense of Ukraine for the performance of state defense tasks. The National Guard of Ukraine, fulfilling the tasks assigned to it, interacts with law enforcement agencies, the Armed Forces of Ukraine, the State Security Administration of Ukraine, other military formations formed in accordance with the laws of Ukraine, local self-government bodies, prosecutor's offices, state authorities, public associations and religious organizations, as well as together with the administration and regime bodies of protected objects and the population.

The main goal of the development of the National Guard of Ukraine is to create within it new units capable of performing a wide range of law enforcement tasks and effectively responding to crisis situations that threaten national security in cooperation with other components of the security and defense sector.

The development of the National Guard of Ukraine will be carried out by: in the first stage (until the end of 2017):

completion of the formation of the legal basis of the National Guard of Ukraine;

deployment of operational military units and special units appointment;

equipping parts and units of the National Guard of Ukraine with the latest and modernized samples of weapons and military equipment, special means and equipment to ensure the protection of public order, technical re-equipment of control and communication systems;

optimization of the number of personnel in accordance with the scope of defined tasks;

reforming the system of material and technical support and creating the necessary military stocks of material and medical property, food, fuel and lubricants;

reforming the system of combat and special training, deployment and equipment centers for training units of operative units;

increasing the level of state social guarantees and other motivations for military personnel;

ensuring the coordinated development of the management system, maintaining material and technical resources, reforming the material and technical system

provision of the National Guard of Ukraine in order to ensure their interoperability with similar systems of the Armed Forces of Ukraine;

in the second stage (until the end of 2020):

increasing the combat capability of the National Guard of Ukraine and the level of its readiness to performance of tasks as assigned;

development of the system of combat and logistical support;

by modernizing the combat system and special personnel training introduction of comprehensive training for the performance of assigned tasks;

creation of operational stocks of material resources;

gradual approach of the National Guard of Ukraine in terms of combat and special training, technical equipment and comprehensive support to NATO standards.

3.5. National Police of Ukraine

The National Police of Ukraine, as the central body of executive power, serves society by ensuring the protection of human rights and freedoms, countering crime, and maintaining public safety and order.

Its main tasks are the provision of police services in the following areas: ensuring public safety and order; protection of human rights and freedoms, as well as the interests of society and the state; combating crime; providing assistance services to persons who, for personal, economic, social reasons or as a result of emergency situations, need such assistance within the limits defined by law.

The main goal of the development of the National Police of Ukraine is the step-by-step creation of a European-style law enforcement agency for further effective performance of tasks.

At the first stage (by the end of 2017), it is planned to carry out:

completion of the processes of forming the structure of the National Police of Ukraine and achieving the optimal number of employees;

transition from a militarized to a social service model of police; ensuring organizational unity and effective management of the system of bodies of the National Police of Ukraine;

depoliticization of the National Police of Ukraine;

creation of the main legal framework for the performance of tasks and functions defined by legislative acts;

provision of units of the National Police of Ukraine with modern special equipment means, special equipment, weapons and the creation of their respective stocks;

creation of special purpose and rapid units in all regions of the state reaction;

reforming the system of recruitment and professional training of employees National Police of Ukraine;

introduction of modern automated information, telecommunication and other systems;

establishment of proper interaction between the police and other law enforcement agencies both at the state and international level, including through joint performance of tasks and coordination of joint actions in case of emergency situations;

the second stage (by the end of 2020) will provide:

bringing the general level of work standards of the National Police of Ukraine to average European indicators;

improvement of the information exchange mechanism with domestic and foreign law enforcement agencies for effective performance of tasks;

expanding the participation of police officers in measures to maintain peace and security in the composition peacekeeping units of the UN, OSCE, etc.

3.6. State Border Service of Ukraine

The main goal of the development of the State Border Guard Service of Ukraine is to ensure the effective implementation of the state policy in the field of security of the state border of Ukraine, as well as the protection of the sovereign rights of Ukraine in its exclusive (maritime) economic zone and in the perspective of the readiness of the state after acquiring membership in the European Union to protect its external borders in the east, north and south of Ukraine.

The State Border Service of Ukraine as a special purpose law enforcement body, the activities of the Administration of which are directed and coordinated by the Ministry of Internal Affairs of Ukraine, is reinforced if necessary in zones and periods of increased threats by the forces of the National Guard of Ukraine and the Armed Forces of Ukraine.

The step-by-step development of the State Border Service of Ukraine provides for:

in the first stage (until the end of 2017):

improving the security system and increasing the level of protection of the state border of Ukraine with the Russian Federation, taking into account real and potential military threats;

completion of the delimitation and demarcation of the state border of Ukraine;

introduction of modern information technologies into the management system and ensuring the protection of information resources;

modernization of the departmental system of coverage of the surface situation and creation of a continuous surveillance zone on the sea section of the state border of Ukraine, development of information interaction with the Naval Forces of the Armed Forces of Ukraine;

formation of rapid response border units;

the organization of joint operational protection of the state border of Ukraine with the member states of the European Union: the Republic of Poland, the Slovak Republic, Romania

and Hungary, as well as with the Republic of Moldova by: introducing joint control of persons, vehicles and goods at checkpoints across the state border; organization of joint patrolling of the state border; implementation of the information exchange mechanism and joint risk analysis; development of cooperation of operative bodies; expansion of the network and functions of border contact points on the common border with neighboring states;

deepening of cooperation with the border service of the Republic of Belarus at the central, territorial and local levels;

improvement of the mechanism of involvement of units of the Armed Forces of Ukraine, the National Guard of Ukraine and law enforcement agencies in peacetime to strengthen the protection of the state border of Ukraine and the sovereign rights of Ukraine in its exclusive (maritime) economic zone, as well as to stop armed and other provocations on the state border of Ukraine;

expanding the powers of operational bodies of the State Border Service of Ukraine, forming an effective mechanism of operational cooperation and information exchange with other law enforcement agencies in the field of ensuring the security of the state border;

improvement of the border control system by creating at checkpoints across the state border of Ukraine subsystems with the functions of processing information about persons who cross the state border of Ukraine and their passport documents using electronic media, in particular with the function of biometric control;

introduction of the procedure for preliminary information about passengers at checkpoints across the state border of Ukraine (control points) for railway connections;

modernization of the system of automated identification of foreigners and stateless persons who are prohibited from entering Ukraine at checkpoints across the state border of Ukraine;

increasing the combat capability of the State Border Service of Ukraine in relation to it the ability to perform the tasks of protecting the state border of Ukraine by:

improvement of the staffing system based on a combination of extraterritorial and territorial principles;

unification and technical re-equipment of management bodies and state border protection bodies of the State Border Service of Ukraine with modern weapons and military equipment, means of communication and informatization;

renewal and modernization of the ship-boat fleet of the Maritime Guard of the State Border Service of Ukraine and the fleet of aviation equipment;

unification of the system of special training of junior specialists and personnel of border rapid response units;

formation of a modern system of material and technical support, effective management of material resources;

in the second stage (until the end of 2020):

equipping the state border of Ukraine with the Russian Federation with modern means of technical surveillance and control, completing the formation of rapid response border units;

building a joint system of operational protection of the state border of Ukraine with the member states of the European Union: the Republic of Poland, the Slovak Republic, Romania and Hungary, as well as with the Republic of Moldova;

introduction of European norms and standards into the border control system and personnel training system;

completion of modernization of the communication and informatization system, updating and modernization of ships and boats of the Maritime Guard of the State Border Service of Ukraine and the fleet of aviation equipment, introduction of unmanned aircraft systems and unmanned watercraft for the protection of the state border of Ukraine;

ensuring the information integration of the departmental system of coverage of the surface situation on the sea section of the state border of Ukraine into the state-wide automated system of coverage of the surface and underwater situation along the sea coast of Ukraine;

ensuring the readiness of the State Border Service of Ukraine to protect temporarily uncontrolled areas of the state border of Ukraine after the restoration of the territorial integrity of Ukraine.

3.7. State Migration Service of Ukraine

The development of the State Migration Service of Ukraine is planned to be carried out by increasing efficiency:

fulfilling the tasks assigned to it and introducing modern transparent procedures for providing quality services, overcoming internal negative phenomena, primarily corruption, as well as restoring public trust in the State Migration Service of Ukraine;

implementation of state policy in the areas of migration (immigration and emigration), in particular, combating illegal (illegal) migration, citizenship, registration of natural persons, refugees and other legally defined categories of migrants.

To achieve the goal, it is assumed:

in the first stage (until the end of 2017):

implement the Concept of implementation of priority measures for the reform of the State Migration Service of Ukraine;

bring the national legal framework and procedural practices into line with international standards, ensure the fulfillment of obligations within the framework of visa liberalization with the European Union;

create a single secure system of electronic document circulation with unified databases;

to develop and implement new models of providing administrative services in cooperation with civil society, enterprises and organizations;

implement a modern tool for electronic identification of a person - a passport a citizen of Ukraine in the form of a card;

to switch to a system of high-quality, affordable, transparent services focused on reduction deadlines for providing administrative services and the number of documents;

ensure operational access of the State Migration Service of Ukraine to existing state and unified registers, other information bases owned by the state, or enterprises, institutions and organizations for the purpose of identification;

provide access to the electronic identification service of the State Migration Service services of Ukraine to state bodies;

develop new services and integrate the passport of a citizen of Ukraine in the form of a card with other e-government initiatives;

ensure the development of access channels to new services and methods of electronic identification, etc.;

in the second stage (until the end of 2020):

strengthen the institutional potential of the State Migration Service of Ukraine, ensure compatibility and complementarity of migration policy with other spheres of state activity;

develop a new model of personal identification and data verification and introduce a new, reliable identity management process (starting from data collection to primary identification and document issuance);

to create a Unified information and analytical system for migration management processes;

to ensure the further development of the infrastructure of the Unified State Demographic Register and the creation of a national identification system for citizens of Ukraine, foreigners and stateless persons;

to improve the mechanisms of involvement of public institutions, scientific circles, international organizations in the control of activities on the formation and implementation of migration policy.

3.8. State Service of Ukraine for Emergency Situations

The goal of the development of the State Emergency Service of Ukraine is to ensure the effective implementation of state policy in the field of civil protection by improving the unified state system of civil protection, bringing it into line with the standards of the European Union and ensuring its effective functioning in peacetime and in a special period, as well as equipping modern types of equipment, means and equipment of civil defense forces.

Development will mainly be achieved through the implementation of measures of the National Target Program for the Protection of the Population and Territories from Emergency Situations of Man-made

and natural nature for 2013 - 2017, approved by the Law of Ukraine dated June 7, 2012 No. 4909-VI.

Achieving the specified goal requires the implementation of measures regarding:

in the first stage (until the end of 2017):

formation of functional and territorial subsystems of the unified state system of civil protection, clear demarcation of spheres of responsibility between them and implementation of control over their effective functioning in peacetime and in a special period;

ensuring the implementation of the requirements and norms of the Code of Civil Protection of Ukraine taking into account the standards of the European Union;

creation of a certain number of fire-rescue units in the garrisons of the Operational and Rescue Service of Civil Protection of the State Emergency Service of Ukraine, bringing their structure and number in line with the scope of the tasks assigned to them;

priority development of pyrotechnic units of the State Emergency Service of Ukraine for humanitarian demining of the territories of the state from explosive objects;

participation in the improvement of the regulatory framework regarding the provision of comprehensive security at critical infrastructure facilities;

improvement of the mechanism of mobilization deployment in a special period and in the case of targeted mobilization of formations of the State Service of Ukraine from emergency situations by creating a reserve of the civil protection service provided for by law;

material and technical re-equipment of management bodies and units of the State Emergency Service of Ukraine with modern equipment, emergency and rescue means and equipment;

increasing the effectiveness of operational and comprehensive response to emergency situations through the creation and development of local and voluntary fire protection units and voluntary civil defense formations:

maintaining the mobile hospital of the State Emergency Service of Ukraine in readiness to perform specified tasks, providing it with the necessary modern equipment and material resources, improving the order of its deployment and functioning;

improvement of the staffing system of bodies and divisions of the State Emergency Service of Ukraine by revising the qualification requirements for specialists in the field of civil protection;

expansion of international cooperation by integrating the State Emergency Service of Ukraine into European and international organizations on civil protection and humanitarian response to crisis situations;

in the second stage (until the end of 2020):

improvement of the mechanism of monitoring and forecasting emergency situations;

taking organizational, economic and engineering-technical measures to reduce risks of emergency situations to an acceptable level;

implementation of a set of measures for the protection of the population provided for by the legislation and the territory from emergency situations;

participation in ensuring stable functioning in emergency situations and in a special period of critical infrastructure objects;

further development of the aviation support system of the State Emergency Service of Ukraine by putting multi-purpose aircraft into operation taking into account the requirements of international standards, moving them closer to regions with a high level of risk of emergency situations;

improving the mechanism of interaction with other structures of ensuring national security through further development of the state emergency management center of the State Emergency Service of Ukraine, formation of a network of relevant lower-level centers and their interaction with the Main Situation Center of Ukraine and other situation centers of the security and defense sector;

modernization of the civil defense communication and notification system, as well as provision its reliable functioning;

implementation of a set of measures regarding the implementation of the emergency system in the state assistance to the population at the single telephone number 112;

ensuring the creation and optimal use of material reserves to prevent emergency situations and eliminate their consequences.

3.9. Security Service of Ukraine

The reform of the Security Service of Ukraine will be aimed at strengthening its capabilities to counter modern external and internal threats to national security and will be carried out in the direction of updating doctrinal and conceptual approaches to the organization of the Security Service of Ukraine, functional optimization of its organizational structure, and improvement of material and technical support.

The goal of reforming the Security Service of Ukraine is to transform it into a special service capable of effectively protecting the state sovereignty, constitutional order, and territorial integrity of Ukraine, which will focus on solving tasks related to:

counter-intelligence protection of state sovereignty, constitutional order, territorial integrity, economic, scientific-technical and defense potential, information security of Ukraine, vital interests of the state, rights and freedoms of citizens from encroachments by special services of foreign states, individual organizations, groups and persons who pose a threat to the national security of Ukraine;

countermeasures against intelligence, intelligence-subversive and other illegal activities of special services of foreign states, individual organizations, groups and individuals that pose threats to the national security of Ukraine;

counter-intelligence protection of state authorities, scientific-technical and defense potential, defense-industrial and transport complexes, the national telecommunications system and their facilities, critical infrastructure facilities of strategic importance:

prevention, detection, termination and disclosure of crimes against the peace and security of humanity, which are committed in cyberspace; implementation of counter-intelligence and investigative measures aimed at combating cyber-terrorism and cyber-espionage; countermeasures against cybercrime, the possible consequences of which directly threaten the vital interests of Ukraine; investigation of cyber incidents and cyber attacks regarding state electronic information resources, information whose protection is required by law, critical information infrastructure and its individual objects; carrying out testing of the readiness of protection of critical information infrastructure objects against possible cyber attacks and cyber incidents; providing response to computer incidents in the sphere of state security;

implementation of a complex of administrative-legal, organizational, operational investigative and operational-technical measures to combat terrorist activity, including international, and terrorist financing;

combating crimes that pose a threat to the state security of Ukraine (with further step-by-step optimization in accordance with the order of powers of the Security Service of Ukraine in this area determined by the law);

exposing and countering transnational and interregional organized criminal groups, combating manifestations of organized crime in various spheres (with further step-by-step optimization in the order of powers of the Security Service of Ukraine in this sphere determined by legislation);

counteracting special information operations and the influence of special services foreign states, organizations, groups and individuals;

fight against illegal circulation and use of special technical means of secretly obtaining information;

carrying out information and analytical activities in the interests of the state security of Ukraine;

prevention of offenses in the sphere of state security of Ukraine.

Achieving the expected result is expected by:

creation of an effective system for countering new threats to the national security of Ukraine in the sphere of state security and improvement of mechanisms for timely identification and response to them within the framework of further development of the security and defense sector of the state;

changes in the legal, organizational and other principles of the functioning of the Security Service of Ukraine, taking into account the modern experience of the activities of the special services of EU member states and

NATO, democratic transformations in society, Ukraine's integration course into the European and Euro-Atlantic economic, political and security space;

a radical update of the content and organization of information and analytical work in the activities of the Security Service of Ukraine, the introduction of the latest information technologies in the process of processing the obtained information, the maximum reduction of law enforcement data in the information arrays of the national special service;

expansion and acquisition of necessary operational and technical capabilities by bodies and units of the Security Service of Ukraine for obtaining operational information;

deepening the interaction of the Security Service of Ukraine with other components of the security sector and defense, state authorities, institutions and organizations on a new basis;

improvement of existing and formation of new mechanisms of partnership relations with special services of foreign countries in accordance with national legislation and international treaties.

3.10. Department of State Security of Ukraine

The development priorities of the State Security Office of Ukraine in the security and defense sector are defined as:

improvement of state protection of state authorities of Ukraine;

ensuring the safety of officials, determined by law, according to their place of stay as both on the territory of Ukraine and abroad;

ensuring the safety of family members of officials defined by law, who live with them or accompany them;

prevention of illegal encroachments on officials and their family members and objects, in respect of which state protection is carried out, their detection and termination;

protection and defense of objects defined by law;

ensuring the safe operation of vehicles intended for officials defined by law;

improvement of the material and technical base of the locations of the Department's subdivisions state security of Ukraine;

re-equipment of units of the State Security Office of Ukraine with modern ones by means of weapons, special equipment, means of communication, automotive equipment;

preservation and accumulation of stocks in order to fulfill the tasks assigned to State Security Office of Ukraine;

participation in measures aimed at combating terrorism.

3.11. State Service of Special Communications and Information Protection of Ukraine

The development priorities of the State Service for Special Communications and Information Protection of Ukraine are:

formation and implementation of state policy in the field of cyber protection of state electronic information resources, information whose protection is required by law, critical information infrastructure and its individual objects, state control in this area;

implementation of organizational and technical measures to prevent, detect and respond to cyber incidents and cyber attacks and eliminate their consequences, informing about cyber threats and appropriate methods of protection against them;

development and improvement of the system of technical and cryptographic protection of information according to the standards (requirements) used by leading European states;

creation of a national telecommunications network, ensuring its uninterrupted functioning and cyber protection;

organization of stable and safe functioning of special information and telecommunication systems that function in the interests of state management in peacetime, crisis situations that threaten national security, and a special period;

ensuring, within the defined competence, cyber protection of information, telecommunication and information-telecommunication systems and networks of objects of the critical information infrastructure of Ukraine, countermeasures and response to computer incidents;

conducting a security audit of critical information infrastructure objects for vulnerability;

improvement of legislation in the field of telecommunications, special information and telecommunication systems, cryptographic and technical protection of information, taking into account EU and NATO norms and standards.

Development of the State Service of Special Communications and Information Protection of Ukraine will be achieved by:

in the first stage (until the end of 2017):

completion of the modernization of the stationary component of the state government communication system, modernization of the governmental field communication subsystem, in particular within the framework of the conversion of the radio frequency resource of Ukraine;

formation National operational and the driving and management of the center of telecommunication of Ukraine, ensuring the proper level of functioning of the cyber protection center as a component of the national system of ensuring cyber security, ensuring the security of state electronic information resources;

development of a unified range of modern domestic means of special communication and information protection, adjustment of their production taking into account the real needs of subjects of the security and defense sector;

creation of a national network of secure mobile communication of state authorities;

development and ensuring the functioning of the National system of confidential communication of the special purpose telecommunication network, in particular in the interests of ensuring the functioning of the network of situational centers:

in the second stage (until the end of 2020):

completion of the modernization of the field component of the state government communication system;

modernization of existing and ensuring the production of developed means and complexes of special communication:

development of international cooperation in the field of cyber security, support of international initiatives in the field of cyber security that correspond to the national interests of Ukraine; intensification of Ukraine's cooperation with the EU and NATO to strengthen Ukraine's capabilities in the field of cyber security; participation in confidence-building activities in cyberspace held under the auspices of the OSCE;

modernization of communication systems of control points of state authorities, local self-government bodies and military command.

3.12. State special transport service

The reform and development of the State Special Transport Service is carried out with the aim of increasing its mobility and equipping it with modern equipment and weapons for the guaranteed performance of engineering and transport support tasks of the Armed Forces of Ukraine and other military formations in peacetime and in conditions of war and emergency, as well as technical cover and reconstruction of transport infrastructure facilities belonging to the Armed Forces of Ukraine and other military formations.

In the medium term, it is planned to integrate the State Special Transport Service into the Armed Forces of Ukraine.

The development priorities of the State Special Transport Service are:

creation of a qualitatively new management system of the State Special Transport Service on a modern technological base;

further optimization of the staff structure and number of united units, their reformation and the transfer of individual units to new states both in peacetime and wartime and bringing the states into line with the tasks assigned to the State Special Service of Transport;

improvement of the personnel training system and mobilization resources;

re-equipment of units of the State Special Service of Transport with modern models of special and automotive equipment.

The development of the State Special Transport Service is achieved by:

in the first stage (until the end of 2017):

improvement of the material and technical base of control points and improvement of the communication system;

introduction of new technologies and forms of construction and reconstruction works;

the gradual transition to staffing by military personnel undergoing military service under a contract;

creation of conditions for the gradual transfer of units of the State Special Transport Service to additional staffing with reservists;

in the second stage (until the end of 2020):

improvement of the management system of the State Special Transport Service and its combination with the management system of the Armed Forces of Ukraine;

further increasing the capabilities of the units of the State Special Transport Service to perform emergency rescue operations and eliminate the consequences of emergency situations at transport infrastructure facilities belonging to the Armed Forces of Ukraine and other military formations formed in accordance with the laws of Ukraine;

modernization, unification and efficiency improvement of the technical equipment system State special transport service;

equipping the State Special Transport Service with modern special models equipment and other material resources;

improvement of the system of material and technical support in order to fulfill the tasks assigned to the State Special Service of Transport;

preservation and accumulation of non-perishable stock and mobilization reserve;

improvement of the personnel training system, provision of a gradual transition to the State Special Transport Service exclusively staffed by military personnel of contract service;

completion of the integration of the State Special Transport Service into the Armed Forces of Ukraine.

3.13. Coordinating body for intelligence activities under the President of Ukraine and intelligence agencies of Ukraine

The main goal of the development of intelligence agencies is to strengthen Ukraine's intelligence capabilities on the basis of their coordinated and clear functioning, coordination of their activities and strengthening of cooperation with partner special services of NATO member states.

The list of intelligence agencies of Ukraine is determined by the Law of Ukraine "About intelligence agencies of Ukraine". In order to improve the effectiveness of the intelligence agencies of Ukraine, the Joint Committee on Intelligence Activities under the President of Ukraine was formed.

The general directions of the development of the intelligence agencies of Ukraine are determined by the National Security Strategy of Ukraine, approved by the Decree of the President of Ukraine dated May 26, 2015 No. 287.

Further development of the intelligence agencies of Ukraine will be carried out through the implementation of measures provided for by the national intelligence program, and will be aimed at:

concentration of efforts of intelligence agencies on priority areas of ensuring national security;

elimination of decentralization, duplication of functions and tasks in the activity of intelligence agencies of Ukraine;

strengthening the interaction of intelligence agencies and coordination of their activities, in particular, by transforming the Joint Committee on Intelligence Activities under the President of Ukraine into a coordinating body on intelligence activities under the President of Ukraine with the corresponding institutionalization of the coordination body;

comprehensive use of the capabilities of intelligence agencies to solve priority tasks;

combination of separate advanced resources and technologies within the framework of intelligence communities of Ukraine;

involvement of consumers of intelligence information in the field of intelligence activities and other subjects of the national security and defense sector;

improvement of the budget financing system of intelligence agencies of Ukraine;

strengthening the interaction of intelligence agencies with partner special services, first of all NATO member states, building relations of mutual trust;

introduction of modern mechanisms of democratic civil control over activities of intelligence agencies of Ukraine.

3.14. Apparatus of the National Security and Defense Council of Ukraine

Development priorities of the National Security and Defense Council of Ukraine are determined by:

information-analytical and organizational support of the National Security and Defense Council of Ukraine as a coordinating body on national security and defense issues under the President of Ukraine;

ensuring that the National Security and Defense Council of Ukraine coordinates and controls the activities of executive authorities and other state bodies in the field of national security and defense;

preparation of proposals for improving legislation on national security and defense, clarification of the National Security Strategy of Ukraine, Military doctrine of Ukraine, other acts on issues of national security and defense;

study and analysis of the situation in the field of national security and defense, the functioning of the security and defense sector of Ukraine and the activities of its components, the activities of other state bodies in this area, preparation and submission to the President of Ukraine, the Council

of national security and defense of Ukraine and, on their behalf, relevant proposals to executive authorities and other state bodies;

ensuring the operation of the Main Situation Center of Ukraine, ensuring, using the capabilities of the Main Situation Center of Ukraine, the effective operation of the unified system of situation centers of state bodies that are part of the security and defense sector;

organization of the functioning of working and advisory bodies of the National Security and Defense Council of Ukraine.

3.15. The central body of executive power, which ensures formation and implementation state military-industrial policy

The main goal of the development of the defense-industrial complex is to create conditions for bringing the defense-industrial complex of Ukraine to a qualitatively new level of production of weapons and military equipment to meet the needs of the Armed Forces of Ukraine and other military formations and law enforcement agencies formed in accordance with the laws of Ukraine, which will make it possible to create a comprehensive a system capable of reproduction and functioning on the principle of balance.

At the first stage (until the end of 2017) - restoration of serviceability, extension of resource, carrying out modernization, creation of new systems and unification of samples of weapons and military equipment of the Armed Forces of Ukraine and other military formations and law enforcement agencies formed in accordance with the laws of Ukraine, as well as systematic formation and structural restructuring of the defense-industrial complex.

At this stage, it is planned to implement measures regarding:

repair and modernization of existing weapons and military equipment;

preparation for serial production of adopted military equipment samples;

improvement of legislative and regulatory support for the development and functioning of the defense-industrial complex;

formation of a new effective system of state management of the defense industry complex;

restructuring and corporatization of defense-industrial enterprises complex;

determination of the possibility of creating closed technological cycles to ensure the priority needs of the Armed Forces of Ukraine and other military formations and law enforcement agencies formed in accordance with the laws of Ukraine according to the specified nomenclature of types of weapons and military equipment;

implementation of import substitution measures and mechanisms;

ensuring diversification of export potential;

wide application of modern scientific methods of labor organization in production;

provision of state support for high-tech enterprises of Ukraine, whose activities are aimed at the development of weapons and military equipment;

introduction of the latest technologies;

improvement of the system of standardization, unification and quality management;

introduction of an effective mechanism of interaction between state customers on defense orders and enterprises of the defense-industrial complex on issues of development and production of weapons and military equipment;

creation of a system of guaranteeing state financial support of defense order projects for the entire period of their implementation; development of military-technical cooperation with partner states;

provision of the Armed Forces of Ukraine and other military formations and law enforcement agencies formed in accordance with the laws of Ukraine with weapons and military equipment produced according to NATO standards.

In the second stage (until the end of 2020) - preparation of production and deployment of the release of the latest samples of weapons and military equipment in accordance with the tasks of the State Targeted Defense Program for the Development of Weapons and Military Equipment for the period until 2020, continuation and completion of the reform of the defense-industrial complex.

At the second stage, it is planned to carry out measures regarding:

preparation and development of serial production of the latest high-tech samples weapons and military equipment;

continuation and completion of systemic structural transformations in defense industrial complex, technical and technological re-equipment of production;

introduction of new, development of basic and critical technologies;

increasing the volume of own production of critical component products and materials, achieving complete independence from the Russian Federation in the production of weapons and military equipment;

active promotion of domestic new and modernized species to the foreign market weapons and military equipment.

The main criteria for changing the number of all components of the security and defense sector there are changes in the security environment and real economic and financial capabilities of the state.

Such changes will be made in order to increase the necessary capabilities components of the security and defense sector and improving their quality indicators.

A promising model of the security and defense sector will be formed by successively increasing operational capabilities to perform tasks as assigned and forming on this basis combat-capable, mobile, adequately trained, comprehensively equipped security and defense forces capable of protecting the national interests of Ukraine and actively participating in international events for maintaining peace and security.

4. Ensuring the development of security and defense sector systems

4.1. Development of the system of management, interaction and control

The development of the management system of the security and defense sector is aimed at ensuring its management as an integral system built on the following principles: establishing cooperation and effective strategic communications between subjects of the security and defense sector; involvement of civil society in the adoption of the most important strategic decisions on ensuring national security; clear regulation of activities in the security and defense sector, which guarantees the stable development of the state; application of adaptive management strategies that involve the involvement of independent expert organizations; transparency and accountability to society.

It is assumed that the President of Ukraine, in accordance with the powers defined by the Constitution of Ukraine, will carry out general management of the security and defense sector, organize the interaction of its components, including:

in peacetime and in crisis situations threatening national security, directly or through the National Security and Defense Council of Ukraine;

in a special period - directly or through the National Security and Defense Council of Ukraine, including using the potential of the Military Cabinet of the National Security and Defense Council of Ukraine and the Staff of the Supreme Commander-in-Chief (if it is created), the working body of which is the General Staff of the Armed Forces of Ukraine.

Control of the activities of the components of the security and defense sector, the President of Ukraine will be carried out directly and through the National Security and Defense Council of Ukraine.

The National Security and Defense Council of Ukraine will coordinate and control the activities of the components of the security and defense sector.

The National Security and Defense Council of Ukraine

The apparatus of the National Security and Defense Council of Ukraine:

will provide informational, analytical and organizational support for the implementation of the National Security and Defense Council of Ukraine in accordance with the legislation on control over the security and defense sector;

will study and analyze, within the framework of the specified powers, the activities of the Armed Forces of Ukraine and other military formations formed in accordance with the laws of Ukraine, their readiness to perform the tasks assigned to them, the implementation by law enforcement agencies of measures to prevent and fight crime:

within the framework of monitoring the state of implementation of the decisions of the National Security and Defense Council of Ukraine, it will analyze the implementation of conceptual and program documents on issues of security, defense, the defense-industrial complex and military-technical cooperation, economic, social and energy security, external and information security, as well as on issues of formation of an organizational and software-hardware complex of monitoring measures necessary for preparation and operational decision-making in the field of national security and defense.

Under the conditions of the introduction of the legal regime of martial law in the country by the decision of the President of Ukraine, the Military Cabinet of the National Security and Defense Council of Ukraine can be transformed into the Headquarters of the Supreme Commander-in-Chief.

The Secretary of the National Security and Defense Council of Ukraine will organize the work of the Headquarters of the Supreme Commander in the event of its formation within the framework of the powers defined by the legislation.

In order to improve the state management of the security and defense sector, timely identification of threats to the national security of Ukraine, the following is envisaged:

to form the Joint Operational Headquarters as a management body for interspecies and interdepartmental groups of troops (forces);

to improve the Unified automated management system of the Armed Forces of Ukraine to work within the framework of the unified management system of the security and defense sector;

to increase the level of strategic management in the field of ensuring national security by creating a network of situational centers that will interact with each other and with the Main Situational Center of Ukraine;

to ensure cyber protection of the network of situational centers of the state, to implement effective measures and means of protection of information of situational centers in the process of its receipt, processing, transmission and preservation;

to create a national system of identification of citizens of Ukraine, foreigners and persons without citizenship;

to ensure constant monitoring and analysis of migration processes in order to develop forecasts of the development of the migration situation in Ukraine and foresee possible risks, including in the field of security.

The network of situation centers of the security and defense sector will be formed as a single organizational and technical complex, equipped with targeted hardware and software and unique information and communication equipment, which will make it possible to improve the quality of information and analytical support and minimize the time for making important management decisions.

In the future, it is assumed:

supplement the specified network with mobile communication complexes that will provide an opportunity to receive and broadcast operational information directly from the scene of events;

to implement a system of continuous provision of information on world achievements in the field of science, engineering and technology, development of weapons, military and special equipment to the components of the security and defense sector, scientific institutions and enterprises of the defense-industrial complex.

4.2. Planning the development of the security and defense sector

The planning of the development of the security and defense sector will be aimed at achieving the necessary capabilities (capabilities) of the components of the security and defense sector, taking into account the forecast of threats to the national security of Ukraine and will be carried out by:

integration of the security and defense sector development planning system into the system state forecasting and strategic planning;

coordination of security and defense sector development planning with budgetary planning taking into account the socio-economic development of the state;

introduction of a planning system based on the capabilities of all components of the security and defense sector, harmonizing this process with program-target and other modern methods of planning financial and other material and technical resources with further development of the concept of development of joint capabilities of the security and defense sector;

development of the principles and implementation of the state risk management system in progress implementation of state programs for the development of components of the security and defense sector;

effective scientific and technical support of program documents regarding the reform and development of components of the security and defense sector, weapons and military equipment, state target defense programs and state defense orders aimed at the implementation of these programs;

coordination, balancing and synchronization with each other in time according to qualitative and resource parameters, taking into account the financial and economic capabilities of the state, the tasks of the state target defense programs for the development of weapons and military equipment, programs for the development of components of the security and defense sector with the State program of reform and development of the defense-industrial complex; determination of the main goals of these program documents, based on the tasks of adapting the weapons system to changes in the nature of wars and armed conflicts, forms and methods of conducting armed struggle, defined by the Military Doctrine of Ukraine, while ensuring the achievement of the established level of technical equipment of the security and defense forces by the end of the program period;

introduction of a unified approach to the development of state target development programs components of the security and defense sector;

increasing the level of coordination of activities of state bodies - subjects of the state defense order (customers) for the effective use of state budget funds, material resources, scientific and production capacities of the state, which will be implemented in the event of the creation of new systems - weapons and military equipment.

4.3. Staff support HR

Staffing of the security and defense sector will include:

staffing of the components of the security and defense sector with professional personnel, mainly contract service prepared according to EU and NATO standards;

preservation of the mixed principle of staffing of the Armed Forces of Ukraine and other military formations formed in accordance with the laws of Ukraine;

creation of an electronic register of conscripts and the formation on its basis of territorial defense forces and a large military-trained operational reserve of conscripts and reservists based on the principle of extraterritoriality;

intensification of the participation of representatives of Ukraine in international exercises, training missions, trainings, educational programs, consultations, internships and other similar activities:

creation of conditions for providing servicemen and law enforcement officers and their family members with housing, primarily official;

improvement of the system of selection, placement, professional training and education of personnel;

strengthening of requirements for candidates for the positions of military personnel, employees of law enforcement agencies and special services based on the introduction of new criteria for their selection with preference given to those who received education in EU and NATO member states;

clarification of the certification system and re-certification based on it military personnel, employees of law enforcement agencies and special services;

improvement of the mobilization training and mobilization system;

provision of social guarantees for servicemen and employees of the security and defense sector, as well as observance of their rights and freedoms;

optimization of the system of higher military educational institutions and educational units of the security and defense sector, organization of training of specialists for the needs of the security and defense sector by state order in related specialties in relevant specialized educational institutions, regardless of their departmental affiliation, with the acquisition of a European level of education recognized as European society;

creation of a state order system for continuous training of labor, technical and engineering personnel to meet the needs of enterprises of the defense industrial complex.

At the first stage (by the end of 2017), it is expected:

introduction of European principles of personnel work;

optimization of the number and ratio of all categories of personnel, overcoming tendencies towards inadequate staffing of primary positions;

formation of a reserve of specialists in the most scarce specialties sufficient in terms of number and level of training to promptly replenish the needs of the components of the security and defense sector;

gradual formation of a professional non-commissioned officer corps capable of ensuring high-quality performance of tasks;

creation of appropriate conditions for gradually increasing the number of troops (forces) staffed by military servicemen under contract and

services in law enforcement agencies, ensuring the proper quality and efficiency of staffing of the security and defense forces in a special period;

improving the quality of selection of citizens for military service under contract and services in law enforcement agencies;

implementation of an effective system of managing the career of military personnel and law enforcement officers:

revision of the term of military service and the conscription age of citizens;

ensuring the further development of service in the military reserve; creation of necessary conditions for military-patriotic education of youth.

4.4. Development of comprehensive support systems for the security and defense sector

The system of logistical support of the components of the security and defense sector in peacetime and a special period will be a combination of technical and rear support systems and, on this basis, the creation of a single system of logistical support of the Armed Forces of Ukraine and other components of the security and defense sector through the unification of their nomenclature and norms provision, with the exception of special nomenclature.

The basis of the logistical support system will be the joint support centers as bodies providing the troops (forces) with logistical means according to the territorial principle, regardless of their subordination.

The priorities of material and technical support will be determined by:

development and implementation of modern technical means of ensuring information security and production of information products in the interests of the components of the security and defense sector:

introduction of a unified system of logistical support for military formations and law enforcement agencies, as well as public procurement for components of the security and defense sector;

development and implementation of unified requirements for military goods;

equipping personnel with modern sets of combat equipment, which will consist of field uniforms at the level of the best world samples and personal protective equipment, night vision devices, navigation and communication devices (with the necessary level of immunity and security), etc.;

creation of a unified number of modern means of special communication and information protection, including those intended for use in field conditions, equipping the components of the security and defense sector with such means;

provision of units with small-sized and inconspicuous field modules for placement of personnel in areas of task performance.

The material and technical support will be based on:

in the first stage (until the end of 2017):

creation of a single system of material and technical support of troops (forces) from the security and defense forces;

autonomous provision is planned along a unified logistics system

maximum involvement of civilian structures in the provision of troops (forces) in peacetime and maintenance of capabilities for autonomous provision of military units in wartime;

taking active measures aimed at receiving from foreign countries material and technical assistance, including necessary weapons and ammunition;

bringing the volume of non-perishable stocks of material resources in line with needs;

in the second stage (until the end of 2020):

creation of a unified register of weapons, military equipment and property, automation processes of accounting, procurement and supply of material and technical means;

bringing operational stocks up to established standards;

transfer of surplus military property that is not suitable for further use military units for disposal in accordance with the procedure established by the Cabinet of Ministers of Ukraine;

equipping the security and defense forces with the latest and modernized weapons, military and special equipment and means;

development and implementation of modern means of communication and information protection for components of the security and defense sector.

The priorities for the development of the medical care system are defined as:

development of field medicine, equipping components of the security and defense sector with protected modern means of evacuation from the battlefield, as well as the creation of mixed aviation units for the evacuation of the wounded;

creation of sufficient capacities for psychological support of military personnel in areas of hostilities, timely psychological assistance to victims;

improvement of the system of training and retraining of military medical personnel;

increasing opportunities for providing medical assistance to persons injured as a result of hostilities, their rehabilitation, in particular psychological and sanatorium-resort treatment;

formation of the Military-civilian medical protection coordination headquarters to ensure the interaction of all medical units of the security and defense sector with civilian medical institutions;

joint use by the Ministry of Defense of Ukraine together with the Ministry of Defense health of Ukraine rehabilitation centers for participants of the anti-terrorist operation;

in the first stage (until the end of 2017):

improvement of the management system of the military medical service, its functional and organizational structure;

optimization of the number and location of military medical facilities;

improvement of the rehabilitation base of health care institutions;

summarizing the experience of medical provision;

performance of applied scientific works using the experience of performing tasks with medical support of troops (forces) in the combat zone;

creation of a psychiatric service in the Armed Forces of Ukraine and other military formations to provide up-to-date psychiatric assistance to military personnel participating in hostilities;

improvement of the system of medical evacuation of the wounded (sick), in particular with the involvement of aeromedical evacuation means (planes, helicopters);

creation of training and retraining branches on the bases of medical clinical centers medical personnel;

training of middle and junior medical personnel for security and defense sector structures in military medical and other educational institutions in the relevant military medical specialty;

deepening international cooperation and cooperation with public and volunteer organizations;

in the second stage (until the end of 2020):

implementation of the latest medical technologies and standards of medical care;

improvement of outpatient and inpatient treatment according to state standards;

introduction of a resource-saving mechanism in medical institutions.

The development of social and humanitarian provision will be carried out by:

strengthening of humanitarian provision of security and defense forces;

maintaining the proper moral and psychological state of personnel;

formation of a positive image of the components of the security and defense sector, comprehensive support from society;

improvement of the mechanism of implementation of social guarantees, benefits and compensations for servicemen and law enforcement officers, their family members and persons released from military service;

increasing the prestige of military service and the social status of military personnel and law enforcement officers in society by conducting a balanced information policy, improving the system of interaction with civil society institutions;

improving the forms and methods of military-patriotic, cultural-educational and educational work among military personnel and law enforcement officers, countering the enemy's destructive informational influence.

At the first stage (by the end of 2017), it is expected:

improvement of the mechanism of providing guarantees of social protection to personnel;

development of a mechanism for the interaction of security and defense forces in countering the negative informational and psychological influence;

determination of the regulatory and legal basis for the interaction of bodies on issues of work with personnel, social and humanitarian policy with religious organizations, ensuring the protection of the personnel's right to freedom of conscience and religion;

development and implementation of the Strategy for the implementation of social policy on long-term perspective;

increasing the amount of housing for servicemen and workers law enforcement agencies and their family members.

In the second stage (by the end of 2020), it is expected:

improvement of the mechanism of control over the state of the social sphere of the components of the security and defense forces on the part of state and public institutions, achieving the necessary level of social security of military personnel;

improvement of the legislation on giving preference to persons released from military service services, during hiring and admission to higher education institutions;

development of the principles for the introduction of the institute of the commissioner for the rights of military personnel to represent and protect the interests of military personnel, their family members, and persons released from military service;

improvement of the system of quartering troops (forces) and provision of housing and service for servicemen;

provision of servicemen who are in military service housing;

introduction of a transparent housing distribution mechanism by providing appropriate housing information on the official websites of state authorities in the security and defense sector;

acquisition (purchasing) and construction of housing, in particular service housing, for military personnel;

development of a mechanism for attracting funds from military personnel and employees law enforcement agencies for the construction (purchase) of housing;

introduction of a transparent mechanism for providing land plots for individual use construction for military personnel and law enforcement officers.

The development of the infrastructure of the security and defense sector will be carried out by:

restoration and development of military infrastructure to meet the needs of the security and defense sector;

the deployment of autonomous military bases with the appropriate infrastructure for the location of military units formed at new deployment locations, in particular with the aim of ensuring a permanent military presence in the east of the state;

optimization of the airfield network and bringing it into line with the requirements for the operation of existing and prospective aircraft models, dispersal of aircraft to ensure the survivability of aviation and the ability of state aviation to perform its assigned tasks, ensuring flight safety;

arrangement of points of joint basing of ships of the Naval Forces of the Armed Forces of Ukraine and the Maritime Guard of the State Border Service of Ukraine in accordance with operational requirements for new models of ships (boats);

creation of a unified system of monitoring the ground, surface, underwater and air conditions;

increasing the effectiveness of the use of military training grounds in the interests of the security forces and defense according to a unified schedule and depending on the places of permanent deployment;

ensuring the dispersion and sheltering in protected warehouses of the entire stockpile of missiles and ammunition of the Armed Forces of Ukraine and other military formations, development of a system for ensuring the survivability and fire safety of arsenals, bases and warehouses;

joint use of the training material base of the Armed Forces of Ukraine with other components of the security and defense forces.

Economic provision of the security and defense sector will be carried out through the formation and implementation of a fundamentally new unified military-economic, military-industrial and military-technical policy.

The main directions of economic provision of the security and defense sector include:

determination at the state level of the long-term needs of the security and defense sector in weapons, military and special equipment, other military products in peacetime and a special period with an indication of its nomenclature and volumes broken down by year;

creation of favorable conditions for the effective functioning and development of scientific and scientific-production institutions, enterprises and organizations that ensure the implementation of military-economic, military-industrial and military-technical policies and determine the scientific-technical and production-technological stability of the defense-industrial complex;

ensuring the development of the scientific-technical, technological and production base of the defense industrial complex, the creation, production and modernization of weapons, military and special equipment, reducing Ukraine's dependence on the import of military and dual-use products, directing the necessary financial, material, technical and intellectual resources to the implementation main tasks in the priority directions of the development of the defense-industrial complex;

prevention of military-technical and technological backwardness of Ukraine in development main types of weapons, military and special equipment;

ensuring timely and at the proper level of repair of the existing weapons, military and special equipment, maintaining it in a combat-ready condition;

creation of a state order system for continuous training of labor, technical and engineering personnel to meet the needs of enterprises of the defense industrial complex;

provision of the needs of the Armed Forces of Ukraine, other military formations and law enforcement agencies with products of military purpose in accordance with the nature and scale of threats to the state, goals, priorities and tasks of military policy (needs of the security and defense sector);

improving the principles of state policy in the field of military-technical cooperation with foreign countries, increasing the effectiveness of international scientific-technical cooperation, primarily with EU and NATO member states;

development, mastering and implementation of the latest technologies;

ensuring, within the framework of the implementation of the State target program for the reform and development of the defense-industrial complex, the formation of in-depth integration of science and production, rational diversification, technical rearmament, the preservation and development of basic and critical technologies, the creation and expansion of the range and volume of production of competitive military and civilian products and dual use to meet the priority needs of the security and defense sector.

Provision of security and defense forces with weapons, military and special equipment, missiles, ammunition, special, logistical, medical and other means will be carried out in accordance with the state programs of their development.

One of the main directions of legal support for the development of the security and defense sector is the normalization of its activities and the adaptation of basic legislative and other normative legal acts, as well as conceptual and program documents to modern realities and requirements, in particular:

development and adoption of a new edition of the Law of Ukraine "On the basics of national security of Ukraine";

development and adoption of the Law of Ukraine on planning in the security and defense sector and other normative legal acts;

development and adoption of the Law of Ukraine on intelligence activities, amendments to the laws of Ukraine "On the Security Service of Ukraine", "On counterintelligence activities", "On operative investigative activity", "On the fight against terrorism", "About intelligence agencies of Ukraine";

development of strategies for logistical support and countermeasures in the communicative environment;

development of the Strategy for the development of the defense-industrial complex of Ukraine, based on the goals, tasks and priorities of state policy in the field of national security and defense, military-economic, socio-economic and scientific-technical development of the state;

legislative definition of the mechanism for coordinating the coverage of information on issues of national security and defense of the state in mass media;

development and implementation of legal acts regarding the revival of the strategic role of the defense-industrial complex, ensuring its reformation, sustainable and effective development.

Improving the legal framework in the field of security and defense will contribute to the formation and implementation of an updated security and defense policy in peacetime, crisis situations that threaten the national security of Ukraine, and in a special period, the readiness of the components of the security and defense sector, the economy and society to repel armed aggression against Ukraine.

The financing of the development needs of the components of the security and defense sector is expected to be carried out at the expense of budget funds in the amounts determined annually in the Law on the State Budget of Ukraine, and other sources not prohibited by law.

The implementation of this Strategy will require an annual allocation of at least 5 percent of the gross domestic product to the financing of the security and defense sector, in particular to defense expenditures - at least 3 percent of the gross domestic product each year, and to ensuring the development of the defense-industrial complex - 0.5 percent gross domestic product.

A component of democratic civilian control is parliamentary control, the implementation of which must be properly financially, organizationally, personnel- and institutionally ensured.

IV. THE ROLE AND PLACE OF SOCIETY IN THE DEVELOPMENT OF THE SECURITY AND DEFENSE SECTOR

The priorities in this direction should be:

1) creation of legal, organizational, and financial and material conditions for the involvement of public organizations and citizens in the process of formation and implementation of state policy on security and defense, in particular, by implementing:

consultations with the public, public hearings, etc., activation of activities public councils under ministries, other central bodies of executive power;

material support and encouragement of public organizations and citizens to carry out research on security and defense issues, taking into account the requirements of the law;

public examination of draft laws, government decisions, concepts, strategies and state programs on security and defense issues;

2) creation of conditions for effective public control over the activities of the components of the security and defense sector by:

expansion of the format and mechanism of informing the public about their activities and performance of tasks assigned to them;

strengthening the responsibility of the leaders of the relevant components of the security and defense sector for timely response to the appeals of public organizations and citizens, reporting to the mass media about their improper performance of their tasks and facts of violations of the rights of servicemen, law enforcement officers and their family members;

3) promoting the participation of public organizations in increasing the readiness of the components of the security and defense sector to fulfill the tasks assigned to them by:

consolidation of various public initiatives and movements in support of the global strategy to counter terrorism, creation of a multifunctional system of anti-terrorist actions and minimization of terrorist threats;

formation of citizens in an active position to counter terrorist activities in any form, introduction of a system of involving the public in countering terrorism to facilitate its detection and prevention;

creation of conditions for involvement of public organizations in the military-patriotic education of youth, preparation of citizens for the defense of the Motherland;

improvement of legislative provisions on the development of the volunteer movement in Ukraine, improvement of the quality of volunteer assistance;

involvement of the public in the processes of development of the components of the security and defense sector, in particular in matters of improving their social, medical and logistical support, rational use of state resources.

To ensure democratic civil control by society and with the aim of highlighting the state policy and strategy for ensuring national interests in the field of national security and defense, the dynamics of achieving the necessary capabilities of the components of the security and defense sector, taking into account the measures taken during the reporting period for their development and the level of comprehensive support of the components the security and defense sector will provide the publication of White books and other informational and reporting materials of a public nature, including on departmental Internet sites.

V. EXPECTED RESULTS

The practical implementation of the Concept will make it possible to form an integrated security and defense sector of the state as the main element of the national security system and an effective state tool for timely and guaranteed response to crisis situations that threaten the national security of Ukraine.

The implementation of the principles of the development of the security and defense sector provided for by the Concept will make it possible to create combat-ready, multifunctional, mobile, adequately trained, comprehensively equipped, professional security and defense forces, which, according to their capabilities, will be able to effectively perform the assigned tasks.

The concept will contribute to the formation of the security and defense sector as a complete functional association managed from a single center, the development of which is carried out on

on the basis of a unified planning system within the framework of achieving joint capabilities capable of adequately and flexibly responding to the complex nature of current threats to the national security of Ukraine, taking into account the presence of simultaneous action of danger factors, different in content and sphere of influence.

The concept is the basis for the development of development program documents components of the security and defense sector.

- ¹ The Ministry of Internal Affairs of Ukraine does not take a direct part in hostilities, but ensures the fulfillment of the tasks assigned to it and the tasks defined by the legislation of the central bodies of executive power, the activities of which are directed and coordinated by the Minister of Internal Affairs of Ukraine, and also carries out the military, political and administrative leadership of the National Guard of Ukraine. In addition, it ensures the implementation of territorial defense measures.
- ² The State Service of Ukraine for Emergency Situations of Direct Participation in Combat does not take action, but protects the population and territories from the consequences of military operations.
- **3** The main responsibility for the execution of the task and the coordination of efforts in peacetime rests: on land, sea, rivers, lakes and other bodies of water on the State Border Service of Ukraine; in the air and underwater space within the territorial sea to the Armed Forces of Ukraine.
- ⁴ The State Border Service of Ukraine carries out protection and protection of crossing points across the state border, military towns of its divisions and management bodies in order to stop attempts to block and capture them, disarm border units (border units); causing harm to life and health, taking hostages of persons crossing the state border, border guards, and their family members.
- **5** The main responsibility and coordination of efforts to eliminate the consequences of mass infectious diseases of citizens rests with the Ministry of Health of Ukraine.
- **6** The Ministry of Agrarian Policy and Food of Ukraine is entrusted with the main responsibility and coordination of efforts to eliminate the consequences of large-scale damage to agricultural plants by diseases and pests and mass infectious diseases of farm animals.

Note. In this appendix, abbreviations are used in the following sense: K - management; BU - direct participation; KZ - coordination of actions (measures); DR - auxiliary role of assistance in execution; GV - the main responsibility; Zb - support (political-diplomatic, organizational, resource, scientific, technical, industrial, economic, informational, etc.).
